

NIGHTTIME CONSTRUCTION FOR SIGN WORK BEGINS IN SUMMER 2019

PROJECT OVERVIEW

The Oregon Department of Transportation is planning to install new ODOT RealTime signs on I-5 which will help make roads safer and help drivers travel more efficiently by providing real-time traffic information.

New advisory speed signs, traveler information signs and relocated guide signs will be installed in seven locations along I-5 between I-405 and Marine Drive. These signs will assist in reducing crashes, improve travel time reliability, and enhance transit operations.

Construction will take place mostly at night to minimize traffic impacts during the day. Work is expected to be complete in summer 2020 but is subject to change based on weather and site conditions.

NOISE IMPACTS DURING CONSTRUCTION

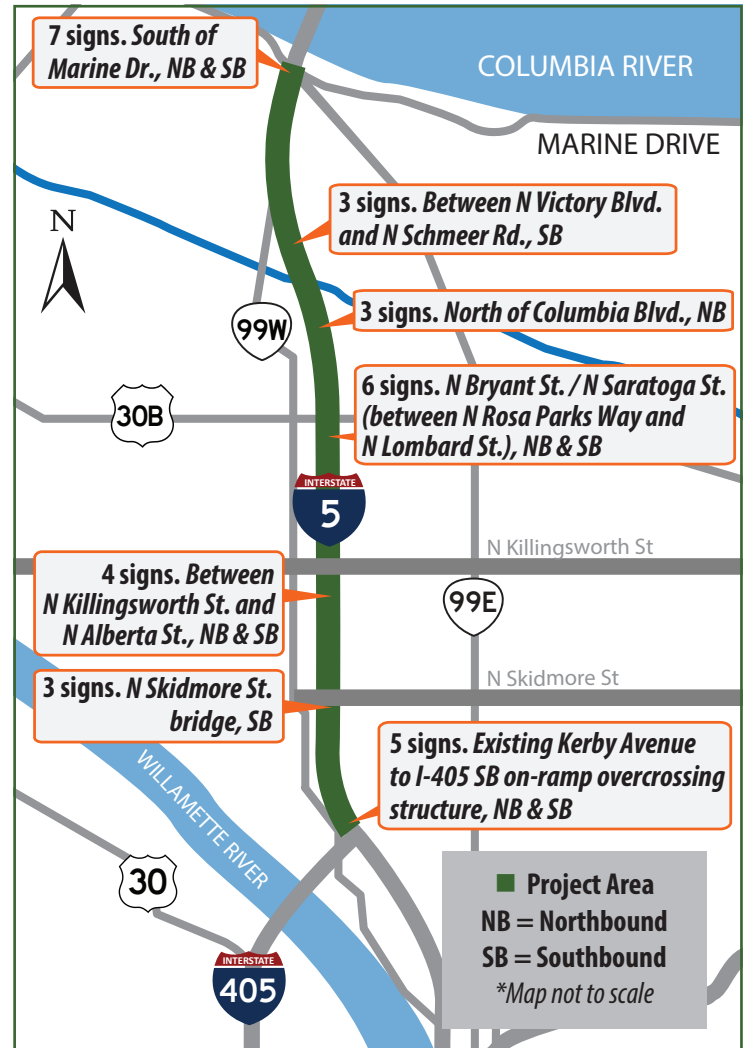
Nighttime construction noise will occur periodically from 6 p.m. to 7 a.m. and those working or living in the area may hear the noise. Noise will come from heavy equipment, construction trucks, beeping noise when construction vehicles are in reverse (a requirement by the Occupational Safety and Health Administration), and equipment such as metal saws and drills.

ODOT is requesting a nighttime noise variance permit from the City of Portland (Title 18). Working at night is necessary to keep daytime traffic flowing on the heavily traveled freeway. As part of the permit process, ODOT will present the noise variance application to the Noise Review Board on Wednesday, January 9th, in order to gain approval. This meeting is open to the public.

Prior to construction, you will receive a notification from ODOT with a noise hotline number to reach a live person 24-hours a day to help resolve any noise problems or incidents.

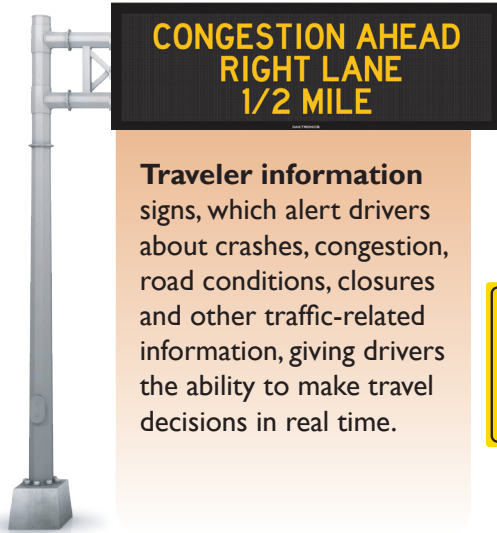

Advisory speed signs, displaying advisory speeds based on the traffic ahead. The advisory speeds will change as real-time conditions change. These signs give drivers a heads-up to slow down before they reach a problem area - helping reduce rear-end crashes and the congestion they cause.
