Adrian Vasile

Proposed Development at 3924 N Montana Ave

- Adrian Vasile presented a project he is building with six residential condominium units with no onsite parking.
- He distributed drawings & renderings, noting that he has built a similar property across the street in about 2016 on Montana.
- Construction may begin a year to a year and a half from now depending when demolition & building permits are granted.
- He will not be adding a floor as allowed if including affordable units.

• Stefan Bester reported that to address the inappropriate use of the purchased houses for office space, a meeting is being scheduled with the Mayor to resolve the situation.

- Chris noted that Tom Hughes had said they were dealing with the issue with regard to where to place mobile offices and port-a-potties in the street.
- Stefan & Chris assured one neighbor that Adidas campus has a no-smoking policy, so any smoking at the corner of the property can be reported.
- Stefan asked the Board if there might be support for zoned parking in Overlook. Several Board members replied with comments on various aspects.

- Public Safety (George)

Parks (Chris)

- Chris reported that Patton Square Park completed its fundraising with \$20K raised plus \$15K
 from City, leaving money at the end perhaps for a celebration to be held at the park.
- Cynthia & her husband have been a member of the Adopt a Bridge program for Failing Bridge over I5 HIghway the past 10 years and has asked for new volunteers. One neighbor spoke up for more information.

Land Use (Derek)

Derek reported that the 1931 N Church St Project—The Nomad--bounded also by Interstate &
Maryland St has indicated that they will be erecting a Crane along Maryland street instead of at
the North side of their half-block project as presented to the Overlook Association by the
Developer in mid-February. The self-erecting style crane is to go up in early autumn.

Transportation (Brad)

 North Willamette Greenway Project with planters and speedbumps from Interstate to Greeley was discussed, and suggested as a possible Overlook Views topic.

Public Comments

- Although the 'Dog Bowl' land at the bluffs is owned by Water Bureau, not Parks, a plan has been revised to go before City Council this fall to make this a Park.
