Chair Report

- Chris called the meeting to order. Went through introductions.
- Joint Office of Homeless Services still no update on Hazelnut Grove other than they are still looking at places that are viable
- Adidas security found homeless person trying to get into a car to sleep. Make sure you lock your car doors at night.

Development at 2054 N Killingsworth and 5833 N Maryland

• Presenter, Kevin Cooper, did not show. Presentation did not occur.

Development at 1935 N Killingsworth (Denver and Killingsworth)

- Though no parking is required, the development will have nine parking spots, 1 handicapped
- Will include both affordable and market value units 36 units total
- The site will be mitigated since it used to be a gas station; will be getting LEED Gold certification
- Timing start in late Fall, 13 months to build
- Will include two retail spaces and outdoor courtyard in the NE corner; sidewalk seating will be on the Denver side

Micro-apartments at 5134 N Interstate

- The building will not have any parking; will have one retail space; loading bay will be off of Sumner
- Will have rooftop solar and bio-swales for storm water management integrated into the sidewalks
- There will be 61 units which range from 200-300sf; 12 affordable, remaining are market value

Overlook Neighborhood Association (OKNA)

Street Parking Permit Pilot

- The City asked neighborhood associations to apply for a pilot street parking permit program if interested and they meet the requirements. There will be a lot of competition.
- For Overlook, there was a suggestion to apply for the blocks near Interstate and/or around Adidas
- There was very little support from the neighborhood residents
- **Decision** the neighborhood residents did not make a motion to support this initiative

Graffiti Abatement Funding Letter

- The Mayor has asked all departments, including the Office of Neighborhood Involvement (ONI), to propose 5% budget cuts; ONI has said as part of that, they would cut all funding for the graffiti abatement program
- The Richmond NA sent a letter to the city and has asked that other NAs submit a letter as well, if they support the program
- Brad Halverson makes a motion to send the graffiti program support letter to the City; seconded by Kristina Kern.
 - Vote: The motion passes with Noelle Smith in opposition.
