## Board/Neighborhood Association Orientation (Tom GV)

- Role of North Portland Neighborhood Services (NPNS part of Office Neighborhood Involvement): provide technical assistance for 11 N/NE neighborhoods. Also provides insurance (3<sup>rd</sup> party liability insurance, director and officer insurance, accident insurance for events for events have list who is working), grant funding (small grant fund in fall from city and fund from Portland Raceway noise remediation in spring), and assist other organizations (including North Portland Tool Library, Interstate Farmers Market, and Frente Comun).
- Why neighborhood association set up as a corporation? Limit individual liability.
- What we have to do to maintain corp. status? Decisions/actions in voice of corporation not individual. Filing with secretary of state and department of justice, IRS. Recognition from city need to file minutes and rosters.
- 501c3 status: My never endorse candidate. Restrictions on lobbying and ballot measure endorsements.
- 501c3 status. In a couple years will need to follow Sarbains-Oxley act. Should file conflict of interest for board, whistleblower policy, compensation committee. Will be training by NPNS in future.
- Suggestion: review by-laws and forms annually.
- City of Portland: need to keep track of commissioners' assignments and work with them as issues come up particularly policy related. Outreach, numbers, participation all key to ability to influence decision makers.
- Boards: Focus on how to communicate so that can be effective when need to. Focus on community building rather than meetings. Board rather than chair take responsibility. Control the agenda (particularly from outside speakers). Guests (developers) pay "price of admission" (e.g., require them to advertise meeting, bring treats). Focus on social networking and minimum meeting length.
- Idea: set 6 month or year agendas (including what is needed to accomplish, evaluate at end, and tell people about it).
- Resource: Asset Based Community Development project from Northwestern University

  - Great committee this year for tree planting. On track for about 60 trees
     (about average) more difficult as reach saturation point after 10 years.
