Chair Report

- Chris called the meeting to order at 6:36 and went through introductions.
- Meeting minutes:
 - Overlook Resident Matt Scroggin moves to issue letter to parks to make the "Dog Bowl" an official dog park and not an off-road bicycle facility as proposed in the Off-Road Cycling Master Plan.
 - Membership vote:** 2 oppose, everyone else in attendance in favor. Motion carries.

Board Reports

- Discussion of "Dog Bowl" and possibility of it becoming an off-road bike park vs continuing being used for current use as an unofficial dog park - do we want to submit letter to parks and potentially testimony
- NET Meeting April 9, 6:30 – 8 pm at Lucky Lab
- Neighborhood clean-up is May 19, 10 – noon; dumpster for use, electronics recycling, tomato plants as gifts
- PSAC steering committee still a possibility

ADIDAS Expansion

- 2 New buildings - total of 5 stories each, 25-foot setback; change in entrance to campus; create 4-way intersection; create new transport hub with bus stop and park type area.
- Process takes a long time, construction to start potentially as soon as the fall and be completed in about 2 years

MURP Students - Willamette Blvd Mobility Project

- Goals to create a plan along an active corridor
- Working with Neighborhood Associations, schools and business, taking surveys and doing presentations
- Also meeting specifically with POC, low income and youth focus groups. Project is being planned through an equity lens
- Gathering data points for problem areas along Willamette Blvd via these groups. Hoping to gather 800 -1000 data points.
- Attendees were given an opportunity to flag problem spots in the transportation corridor on a map and to provide comments.

Greeley Ave Multi-Use Path

- Includes concrete barrier for bikes and bike signal.
- PBOT is still reviewing the proposal and it could change.
- Success would be less bike vs. car accident.
- Community feedback- narrow for multi-use, confused as to how it will be cleaned, no shoulder for cars seems dangerous

1215 N Albert St Development

- 14 units High Density units at Market Rate
 - Bike parking only, no car parking
 - Courtyard for residents, lighted walkway on Alberta side, 14ft cedar screen
 - 6 units on ground floor - 400 sq ft studios, 4 units on 2nd and 3rd floor - 560 sq ft
