Chair Report

- Chris called the meeting to order at 6:35pm.
- Approval of prior meeting minutes
 - o Motion: Alexandra moves to approve the minutes from Aug 7; Mike Shea seconds
 - Board Vote: Chris asked if any objections to approving the minutes. No objections.
- Works Progress Architecture at Denver and Killingsworth project has been quiet
- September meeting
 - Will have pro and con presentations for the ballot measure on taxing very large businesses;
 funds will go to environmental projects in low income neighborhoods
 - ODOT will present on their project to shut down one side of the I-5 bridge in 2020
- Defend Oregon wants to present at our Oct meeting
 - Board members did not support due to lack of time and having to find people to represent the other view

Heritage Tree Update

- Public hearing on July 23; attendance from the neighborhood was significant
- Several experts presented; arborists presented that the tree needs 1.5'-2' of protection for each inch of tree diameter
- FOOB wants the tree to be owned by a single person; wants further protection
- If things do not go FOOB's way, they would like OKNA to put in an appeal

• Board Decision: Chris may call a special meeting to decide on whether to support an appeal

Portland Harbor Superfund

- The Portland Harbor Community Advisory Group does not feel that the City is doing enough to inform residents about the superfund site.
- They would like to a website that has information on the cleanup and pollution levels, as well as signs to alert boaters and swimmers about the cleanup
