#### Response from Warren Cassell (Co-editor Overlook Views) to the OKNA Board mailing list.

#### Dear Amy,

*I have been attending Board meetings for the* last six months and agree that the Board is not an adequate reflection of the neighborhood's make-up. However, I strongly disagree that the meetings are a waste of time. Last night the Board spent an hour and a half discussing the non-Triangle issue of a housing development on *Killingsworth. They have spent a considerable* number of hours discussing and taking action on the non-Triangle issue of the adult video store. In other words, the Board discusses issues that affect everyone from Overlook to Ainsworth and in-between. I think all Board members would prefer more diversity on the Board and an effort has to be made to accomplish that goal. Perhaps you could be a driving force in this area, should you choose to remain on the Board. And even if you didn't, perhaps you could influence your friends and neighbors north of the Triangle to attend general meetings and get involved in the business of the Association.

One of the reasons we started a newsletter was so that we could better communicate with all areas of the neighborhood, not just the Triangle. An article in a recent newsletter concerning the relationship between the city and neighborhood associations was in response to a non-Triangle resident's request. We are certainly open to suggestions from Overlook residents no matter what part of the neighborhood they live in.

Amy, I'm glad you wrote. We need people like you, who care enough to speak out, to make the organization a viable resource for the entire neighborhood. As a co-member, I hope to see you at future meetings.

#### Editors' here and now (non email) Response

Well-said Amy---but recent discussions at the board and general meetings have centered on topics definitely NOT A WASTE OF TIME.

# Following is an excerpt from Brad Halverson's summary of the OKNA general meeting held on September 21<sup>st</sup>.

After the elections, we continued the discussion from July's general meeting about Section 8 housing in the proposed Killingsworth Station development. The Portland Development Commission (PDC) requires allowing Section 8 (subsidized) housing at all of the projects they fund. The developer and PDC staff reviewed what Section 8 housing was, financial qualifications for tenants, and the differences between tenant-based (voucher) and project-based Section 8 units. A thorough discussion ensued after the presentation. The OKNA members in attendance voted 23 to 9 to oppose placement of project-based Section 8 housing at Killingsworth Station. A letter stating the position will be sent to PDC. I believe we all came away from the meeting with a better understanding of the issues. (PDC staff took our

recommendation back to their leaders and has now removed <u>project-based</u> Section 8 units as a funding mechanism for the Killingsworth Station project.)

This meeting elicited a vigorous e-mail response from another active neighborhood association member concerning diversity in the OKNA and resulted in some questions and editorial comment of our own.

... I am very disappointed in the neighborhood association. They (Section 8 families) are after the American dream like everyone else. They want the best for the their families and children. Stability is what they need-otherwise they shuffle their children from apartment to apartment---and this is the #1 reason why low-income children fail in school. ... Section 8 families often struggle more than anyone in their comfortable homes in Overlook could ever comprehend. I am getting disillusioned with our neighbors. The world does not look like the Overlook triangle. In my opinion, the board should stop meeting at the Overlook House and should cross the divide and meet in the other half of the neighborhood. If not all the time, at least occasionally. ...I'm really wondering what our Association was thinking re that vote.

#### Your editors' response

Well, what <u>are</u> we thinking? What does voting down Section 8 at Killingsworth say about us? Just that we like the status quo? That we "profile" all Section 8 candidates in one negative way? That we are complacent about diversity? Do we just talk the talk but not walk the walk?

It's just a little ball of rock.—We've got to live on it together.

Two couples, neighbors who didn't know one another well, met at the totem poles, donned orange jackets bearing the slogan, "Neighborhood Watch/Prevent Crime," and ventured out. The patrol wove through the Ockley Green neighborhood -- up Colfax and Montana in Arbor Lodge, down Maryland and Simpson in Overlook. They took every opportunity to traverse the intersection of Interstate and Ainsworth, where a sex shop stands a stone's throw from the school playground. They noted graffiti, hazards on sidewalks, broken bottles. They visited businesses. They got to know one another as they strolled through the dusk. And they met neighbors -- new homeowners on Concord, a young couple with a baby, a boisterous man at George's who showed off his new truck, a teenage girl on the steps of the bowling alley who complimented them on the orange jackets. After two hours of walking, talking, watching, writing, they were tired yet exhilarated. There were no major crimes to report, and the experience was worthwhile in ways they had not anticipated.

Often it seems there is nothing individuals can do to make a difference. Bureaucrats are unresponsive, laws do not keep sex shops out of neighborhoods, the voice of a neighborhood goes unheard. But one can take steps. The Ockley Green Foot Patrol is taking steps for a safer and better neighborhood. At this writing we are scheduling two-hour patrol shifts throughout the week, and no one will be asked to walk more than two shifts in a month. Please join us.

The busy event season (Summer), which provides most of the necessary revenue to pay for the ongoing upkeep of Overlook House, is behind us. Marcella McGee, treasurer of OH by night and CFO of Self Enhancement, Inc. by day has calculated that paid revenues exceed expenses by an amount sufficient to allow us to get through the much slower winter season with a modest surplus to spare. The OH Steering Committee is now trying to plot the course for the next year. We are in need of a paid lead staff person working 10-20 hours per week, to handle scheduling and use coordination. 




