Chair Report

- Alesandra asked if for a motion to approve the agenda

Development at 5606 N Maryland

- Steve Foster presented 5606 N Maryland development:
 - There will be 4-one bedroom units per floor.
 - The timeline for this project is a spring 2022 start construction
 - Several residents near the site spoke to the lack of parking for such a large building. They also had several questions for the OKNA land use chair:
 - What is Overlook doing to talk/pressure the city? What are they doing to evaluate the concerns of residents to the city?
 - What is the status of this project and who has control of the site (the residents of the house in question have had several people on the property unannounced).
 - What can we do to stop the amount of development in this area? Currently there are 5 projects of this nature.
 - What can OKNA do to advocate for more traffic & pedestrian safety in this area?
 - These streets are very narrow, there is limited site and traffic control including a lack of real pedestrian infrastructure along Montana & Maryland.
