The new board members introduced themselves to the public! (John Carter assigned to come up with an OKNA theme song before next meeting)

Open Business

Overlook Views bios and photos were due on 10/20/21 by end of day so as to ensure on-time publication!

New Business

Works Architecture and Yoni Schwartz (Developer) were on the call to answer questions about a new **32 unit**, **3 story**, **inclusionary zoning apartment building** (1560 N Going LLC). Works gave a short presentation on the layout of the property.

- Currently the site is a vacant lot.
- Walled in by a sound wall the developer cannot modify.
- 5 of the units (IZ) are 80% 'market rate' in pricing.
- Email info@worksarchitecture.net with any questions or concerns regarding the development.
- Development Notice stolen and not replaced
 - The notice needs to be in a more visible and accessible location (N Prescott)
- No on-site parking, bike parking provided developer is hoping to attract transit/bike centric residents.
 - Based on estimated data, less than 50% of tenants will not have cars.
 - There were concerns expressed about the lack of off-street parking.
- There will be an easement on the property for emergency vehicles
- Concerns raised about an abandoned house adjacent to the development attracting squatters.

Nic Cota made a presentation on North Portland in Motion, the city's transportation improvement plan for our part of the city.

- Mike Serritella can be emailed about concerns or questions regarding the project (Mike.serritella@portlandoregon.gov).
- Community engagement efforts include:
 - Community Advisory Group (for which Nic is on).
 - Planning effort for how to direct funding and investments.
 - Looking at 'quick build' projects to get high impact within a shorter timespan.
 - 'Equity' efforts will be given priority
 - Community support backing will make it easier for PBOT to use 'Fixing Our Streets' funding for these projects.
 - There was a survey on the survey sent out less than 10% of Overlook sent responses.
 - Bus service will also be taking priority current service is too slow, there need to be projects that increase transit priority.
 - The plan will go to the City Council for a vote in 2023.

Board Reports

Brad motioned to approve the minutes from the last board meeting. Motion seconded. Motion passes (7:31pm). Brad also spoke on the Columbia River Crossing, Hayden Island Interchange.

George mentioned a Public Safety Action Committee meeting on Thursday 21st (psac.nne.pdx@gmail.com). He also said his priority on the board is to see how we can increase neighborhood participation and engagement, and focus on what we do and what we want to accomplish.
